Section A: Skill Explained

A hairdresser generally works in the commercial sector, offering a range of services and treatments to the hair for individual clients. There is a direct relationship between the nature and quality of the service required, and the payment made by the client. Therefore, the hairdresser has continuity responsibility to work professionally and interactively with the client in order to give satisfaction and thus maintain and grow the business. Hairdressing is closely associated with other parts of the service sector, and with the many products that support it, normally for commercial purposes.

Hairdressing also has an important therapeutic role in supporting individuals' selfesteem and confidence. It also helps to relieve the effects of illness and can aid recovery.

The hairdresser works in diverse environments including large, medium, small, or mobile salons, client homes ad in product companies and training institutions, film and televisions productions, theatre, wig work, hair replacement, technicians, session stylists and product research and design. He or she may offer a wide range of services, including cutting, colouring, styling, chemical reformation, and special hair treatments. Alternatively, the hairdresser may specialize, for example by becoming either a men's or ladies' hairdresser, or a colourist. Irrespective of this, work organization and management, communication and client care, the ability to analyse hair types and conditions, and to work safely and to manufacturers' instructions, are the universal attributes of the outstanding hairdresser. In a mobile labour market, the hairdresser may work in teams, or alone, or in both from time to time. Whatever the structure of the work, the trained and experienced hairdresser takes on a high level of personal responsibility ad autonomy. From safeguarding the health and wellbeing of the client through scrupulous attention to safe working, to achieving exceptional effects for special occasions, every treatment matters and mistakes are largely irreversible.

With the globalization of visual imagery, the worldwide market in hair and beauty products, and the international mobility of people, the hairdressing faces rapidly expanding opportunities and challenges. For the talented hairdresser there are many commercial and international opportunities; however, these carry with them the need to understand and work with diverse cultures, trends, and hair types. The diversity of skills associated with hairdressing is therefore likely to expand, with the WorldSkills Competition reflecting the skills and attributes of the most outward looking and talented entrants to the sector.

TIME: 2 hours 45 minutes

<u>Rational</u>

The competitor needs to do a commercial haircut & style the mannequin hair into an everyday hair style worn by a fashionable international client. The competitor will get an inspiration for cut, color & style in a mystery Box provided to them at the time of the competition by an external expert team.

<u>Hairpiece</u>

The competitor will also receive a hairpiece that they will have to color in the same time of the test and match it to the hair colour used on the mannequin by them. The hair piece need to be coloured & blow dried at the end of the module and left to be assessed by the judges.

Styling Tool

The competitor will choose the styling equipment based on the texture effect they have been asked to create keeping the mystery Box Request in mind which will be provided at the time of the competition.

MODULE B – LADIES FASHION HAIRSTYLE WITH HAIR EXTENSION

DONE ON A MANNEQUIN USED IN MODULE A

TIME

1 hour 30 mins

Mystery Box: Design Inspiration

Rational

The competitor needs to create a high fashion editorial hairstyle on the mannequin with a picture / word reference. The competitor will have to use the hair pieces that they colored in Module A and create the hairstyle keeping the inspiration in mind.

Hair Piece

It can be cut and styled. All of the hair pieces has to be used in this module

All styling products are allowed.

MODULE C – MEN'S PERM & BEARD DESIGN

DONE ON A MANNEQUIN – PIVOT POINT MANNEQUIN GIOVANNI

TIME

2 hours 45 mins

Mystery Box

<u>Rational</u>

The competitor will need to perm, cut & style the mannequin's hair & beard. The competitor will receive a mystery Box which will hold the wishes for the test.

MODULE I – MEN'S CHEMICAL STRAIGHTENING & TRADITIONAL TAPER CUT WITH BEARD DESIGN

MANNEQUIN: DONE ON THE SAME USED IN MODULE C

TIME

2 hours 15 minutes

Mystery Box

<u>Rational</u>

The competitor needs to chemical straighten the hair of the mannequin which was permed in Module C after which the competitor needs to cut & style the hair keeping the mystery box inspiration in focus. The beard of the mannequin needs to be cut, trimmed & styled to suit the haircut & the back of the mannequin head needs to be tapered.

MODULE D – LADIES CATWALK DESIGN

DONE ON A LIVE MODEL WITH PRE COLOURED HAIR

TIME

1 Hours 30 minutes

<u>Rational</u>

The competitors have to create a fashionable catwalk style on a live model. The mystery box will have an inspiration for the competitor to style the hair.

MODULE E - LADIES LONG HAIR UP ON A LIVE MODEL

DONE ON A LIVE MODEL WITH PRE COLOURED HAIR

TIME

1 Hours 30 minutes

Mystery Box: Two skills will come together to do complete the test: the Mood Board will be given by an external Design and Fashion expert. The live model will be wearing a designer outfit.

Rational

The competitors need to create a fashionable long hair up hair style that would be worn by a model for a elegant evening event. The competitor will receive a mystery box that will have a mood board inspiration from an external fashion expert. The hairstyle needs to compliment the model's face, body structure & outfit.

Section E: Instruction for Competitors

- 1. Competitor can not wear any kind of Branded tool/pouches, uniforms, Tshirts that support a company, school or association. Logo to ensure fairness.
- 2. Capes & Aprons that are used by the competitor on the competition floor can not have any kind of Branding, logos of companies, schools or association.
- 3. The competitor has to wear closed toed, comfortable shoes for hygiene & safety reasons.
- 4. Competitor can not talk to anyone , Jury or another competitor once on the competition floor and also during the competition is progress
- Competitor can not talk to Jury outside the competition floor.
 If a competitor needs clarification of any kind, the competitor needs to put his/her hand up, the competition floor team will provide clarification.
- 6. If a competitor injures themselves the competitor is required to put his/her hand up. The FIRST AID assistance will be immediately provided to the competitor. Time keeper will record the time & give additional time to the competitor.
- 7. If specific equipment fails or there is a malfunction that takes place or the competitor runs into a problem when on the competition floor, the competitor is required to put his/her hand up immediately. The electrical team & competition floor team will assist. The Time keeper will record the time & give additional time to the competitor.
- 8. All competitor will receive:
 - a) Time schedule for the day.
 - b) Competitor Badge
 - c) Model number/station number
- 9. Competitors need to be on the competition floor on time, no extra time will be given to them if they are late on arrival on the competition floor.
- 10. The competitors are only allowed once Chief Expert allows them.
- 11. The competitor can not carry camera's, cell phones on the competition floor any equipments that can do any sort of recording is not allowed.
- 12. The competitor will not touch the hair after the Bell rings marking the end of the competition.
- 13. Once the bell rings. The competitor will be given 5 additional mins on the competition floor to clean station, pack up tools. BUT HE/SHE CAN NOT TOUCH THE HAIR.
- 14. The competitor needs to take away all tools equipments once the competition ends & the mannequin head needs to remain seated at the station till the competition floor director allows them to leave the competition floor once the judging is over.
- 15. The competitors need to brush all their hair back before they start of the competition, he/she should step away from their model & wait for the Chief Expert to start the competition.
- 16.If a competitor starts to use any material, equipment, implement tools or accessories that are not part of the module criteria, the competitor will be

asked to stop using it immediately. Infraction penalty has to be witnessed & agreed by at least two of the Jury members.

17.India Skill reserves the rights to cancel or schedule any competition deemed necessary.

Section F: Health, Safety and Environment

- 1. All accredited participants and supporting volunteers will abide by rules and regulations with regards to Health, Safety, and Environment for the Competition Venue.
- 2. All participants, technicians and supporting staff will wear the required protective Personal Clothing.
- 3. All participants will assume liability for all risks of injury and damage to property, loss of property, which might be associated with or result from participation in the event. The organizers will not be liable for any damage, however in case of injury the competitor will immediately inform the immediate organizer for medical attention.
- Competitors will ensure they will be dressed professionally every day with:
 The hair needs to be styled away from the face.
 - 2. All competitors need to wear closed shoes on the competition floor
 - 3. Wear Apron while working
 - 4. Protective gloves and masks while doing chemical services
